- (d) knowingly or recklessly to provide information under Section 30(1), 31(2), 31(3) or 31(7) of the Localism Act which is false or misleading;

is a criminal offence under Section 34 of the Localism Act, punishable by a fine not exceeding level 5 on the standard scale (currently £5,000), and disqualification as a Member or Coopted Member of Winchfield Parish Council or any other relevant authority for a period not exceeding five years.

I also understand that I must, within 28 days of becoming aware of any new interests, provide written notification to the Clerk.
